**Terms and conditions**

Information on how to enter and prizes forms part of these conditions. Entry into this competition for the Prizes (the “**Promotion**”) is deemed acceptance of these terms and conditions.

**Definitions**

“**Promotion Period**” is the time between 9:00am (NZT) Friday 24 November 2017 and 5:00pm (NZT) on Friday 8<sup>th</sup> December 2017.
